# SUJET 1

Le sujet porte sur la thématique « Relation au monde »

## **Partie 1 : synthèse en anglais (16 pts)**

## **Partie 2 : traduction en français (4 pts)**

All appear to be looking in different directions, as, indeed, they were.

## Document A

### **The United States used to have cachet in China. Not anymore.**

“Soft power” is even more important during times of sharp words and military bluster, but the cultural appeal of American culture and ideas has waned in China.

5 There was a time not so long ago in China when anything American was automatically seen as better. In the 1990s, weddings were held at a McDonald’s near Beijing’s Tiananmen Square. By the 2000s, Nike sneakers, iPhones and dates at Pizza Hut were the badges of middle-class achievement.

10 America, which is called “Meiguo” or “beautiful country” in Chinese, was the bastion of wealth and ease. Even the moon hung larger in the United States than in China, people used to joke.

15 Now, Chinese media and commentators mockingly refer to the United States not as “Meiguo” but as “Meidi” — “the beautiful imperialist.” And Chinese shoppers are more likely to be sipping a drink from Luckin, a Chinese coffee chain, than Starbucks or lining up all night to buy Huawei’s Mate 60 Pro than the latest Apple device. Today, no one says the moon is any different when seen from the United States.

“Back in the days you looked at American brands you just felt they were cooler,” said Tracy Liu, a 30-year-old translator in Shanghai. “Now people chase after domestic brands.”

20 For decades, this soft power was one of the United States’ most potent weapons in China. But over the last few years, the U.S. has lost hearts and minds in China as its cultural luster has faded.

25 The shift comes as Beijing is expanding its military and technological prowess — and as China’s reputation in the United States has plummeted dramatically amid concerns that it will use underhanded tactics to achieve leader Xi Jinping’s vision of a world where the United States and China are equal.

Together, these two trends push the countries further away from each other, and closer to conflict.

30 “If you want to avoid war and you want to manage a competition or you want to manage a common problem like climate, a degree of soft power helps both countries,” said Joseph Nye, former dean at Harvard’s Kennedy School of Government, who first popularized the term soft power in the 1990s and served as U.S. assistant secretary of defense, often dealing with China.

35 “If there’s mutual desire to accomplish those objectives, then the extent to which China is attractive in the U.S., and the extent to which the U.S. is attractive in China can be beneficial to both countries because both countries want an atmosphere that encourages cooperation,” he said.

## Document B

### **Ping-Pong Diplomacy by Nicholas Griffin — review**

5 Nicholas Griffin's history  
deftly captures the bizarre  
moment when table tennis  
lay at the heart of US-  
China relations.

10 There is a photograph,  
taken in 1971, of one of  
the most unlikely groups

ever assembled in the Great Hall of the People in Beijing. In the back row, Glenn  
Cowan, a long-haired American college student; at centre front stands the late Chinese  
premier, Zhou Enlai, at his side an elderly bespectacled Englishman. All appear to be  
15 looking in different directions, as, indeed, they were.

The occasion was the historic visit of the US ping-pong team to Beijing in response to  
an ostensibly impromptu invitation from their Chinese counterparts, issued at the World  
Table Tennis Championship in Japan after Cowan, an American player, boarded the  
Chinese team bus. It is credited with breaking the ice between China and the US after  
20 a 22-year freeze and paving the way for Henry Kissinger's secret trip and President  
Nixon's 1972 visit. China rejoined the world after decades of isolation.

The men who brought this about, as Nicholas Griffin's deft account *Ping-Pong  
Diplomacy: Ivor Montagu and the Astonishing Story Behind the Game That Changed  
the World* makes clear, were a strikingly motley crew. Montagu was the un-sporty son  
25 of a British peer who compensated with ping-pong, a game invented by a British toy  
manufacturer. At Cambridge in the 1920s, he joined the Communist party, codified the  
rules of the game and founded the English Table Tennis Association, followed by the  
International Table Tennis Federation. He had a political motive: he saw ping-pong as  
a vehicle for promoting communism; China was his greatest triumph.

30 Zhou Enlai's motives were equally mixed. He seized on ping-pong as a non-threatening  
means of establishing contact with the US and a way out of China's isolation. The  
"impromptu" invitation was as carefully choreographed as the subsequent visits.



## SUJET 2

## Document B

**There's no right to roam<sup>1</sup> over a staggering 92% of England. I've decided to take a stand.**

Right to Roam<sup>2</sup> believes people should respectfully explore the land on their doorstep: after all, we pay subsidies for a lot of it.

5 Today, barbed wire<sup>3</sup> is an accepted feature of the countryside; a misanthropic aberration faded into the background of daily life. It is the symbol of a sick culture that fetishises private property rights at the expense of all that is good, humane and beautiful. That's why I and others have taken to mass trespass. [...]

10 Trespassing is portrayed as antisocial, but what could be more antisocial than the Keep Out sign and the lacerating wire strung up to reinforce it? The real crime is not the wanderer, it's the fence. [...]

I called an old schoolfriend for an unlikely caper. What if we pretended we lived in Scotland for a day, where the right to roam has been enshrined in law since 2003? What might we do? The answer seemed obvious — finally get to know the river.

15 We didn't get very far — barbed wire, it turns out, is some deterrent — perhaps 5 km upstream and 5 km back. And yet a new world was opened to me. I discovered a beautiful spot a 10-minute cycle from my house, an old estate where the river is lined with mature ash. I've laid in it for hours since, watching dippers and kingfishers scoot past at frog's eye view.

20 Connecting to the river also meant I started to look after it. I started to rummage around the local weir to collect the agricultural rubbish that gets trapped there. I've invested in a phosphate reader to start testing the river quality. Yes, sometimes the public drop litter too. But the flipside of disregard is guardianship.

25 Something else emerged, as well. [...] The river began to shape me, and I came to see that we have lost more than just access: we have lost the chance to belong. [...]

30 No more. It's time to end the farcical privatisation that means there's no right to roam over a staggering 92% of England (and a whopping 97% of its rivers off limits to the public). Right to Roam calls for people to respectfully explore the land hidden on their doorstep. Critics like to say England is too crowded to enjoy the same benefits as Scotland and many other European countries. But then they would think that — they're all sharing the same 8% of it. England is not full, it just feels like it.

## Document C

Labour<sup>1</sup> has, without consultation, promised to give the public unrestricted access to virtually all rural land, ignoring the need for such land to be protected for the purposes of food production, natural habitats and the vast array of environmental projects being undertaken by landowners. Put simply, this act feels entirely incompatible with Sir Keir [Starmer]'s claim that Labour is becoming the party of the countryside.

We already have a fine network of public access. 140,000 miles of public footpaths exist in England and Wales, as well as 3.5 million acres of public access land and significantly more in permissive access.

Labour did not commission any ecological studies in the development of its policy, so the truth is that they have no idea what impact it will have on nature. To the best of our knowledge no studies have been done on the impact on public safety, despite people dying from cattle attacks every year. How many more wildfires will there be? How many more sheep will be attacked by dogs? What damage will be done to crops? As far as I can see, Labour adopted this policy because it's fashionable among some of their voter base, but without really looking into the consequences at all.
